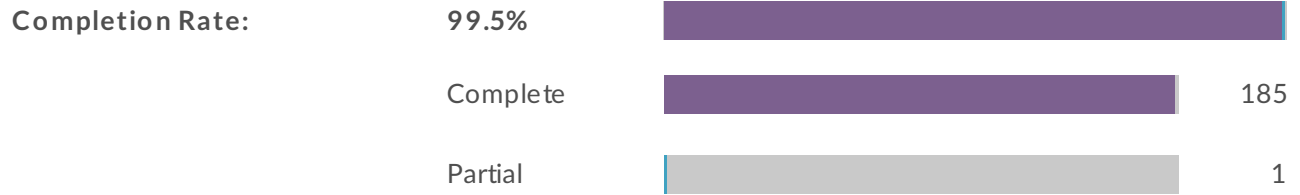

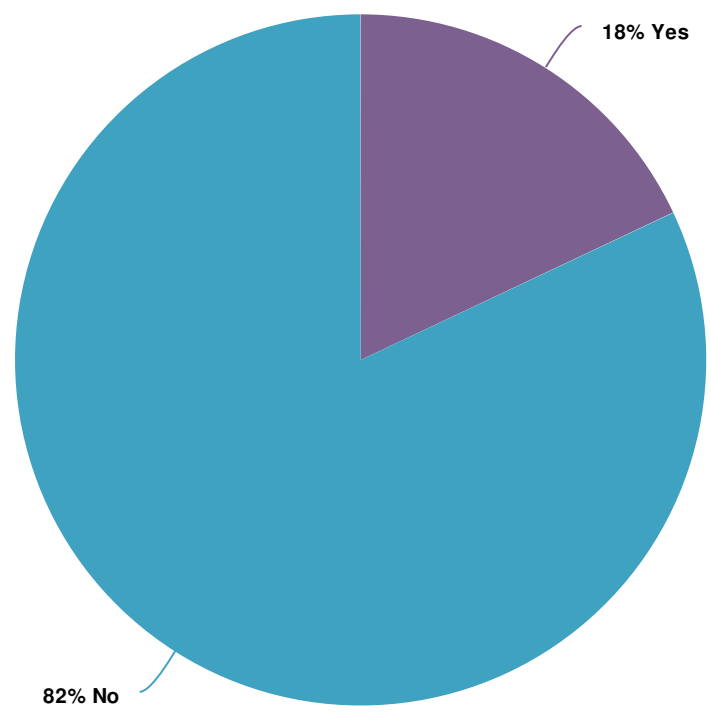

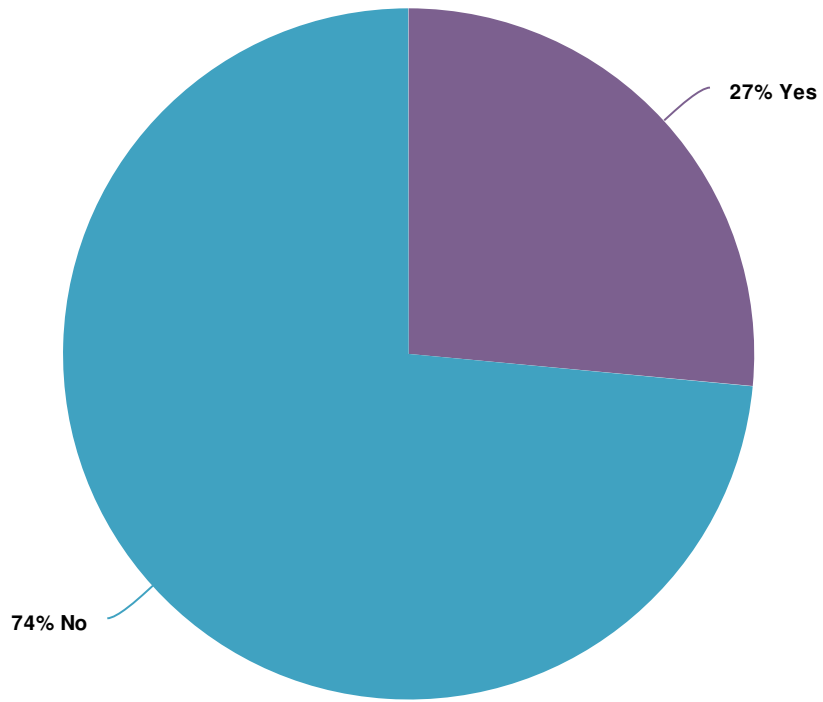
1. Do you own or are you currently planning on purchasing an All-Terrain Vehicle to be used in Desert Aire?

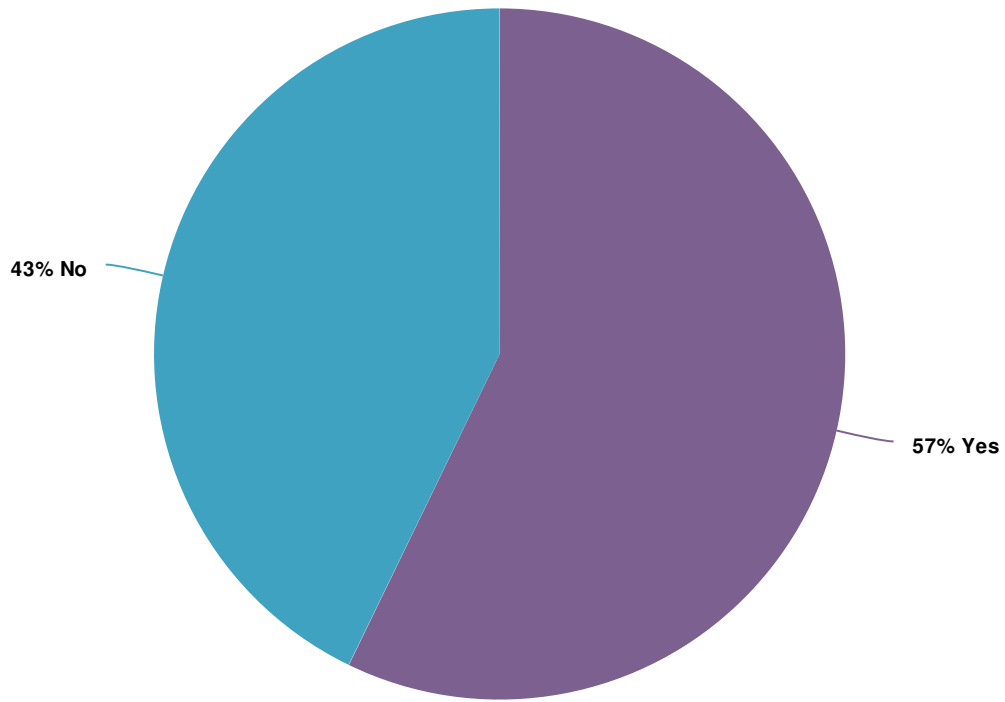
2. Have you experienced any bad involvement with any All-Terrain Vehicles around your property or any other areas in Desert Aire?

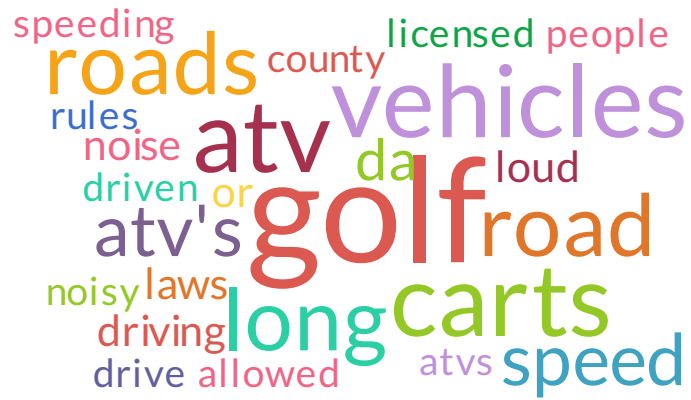

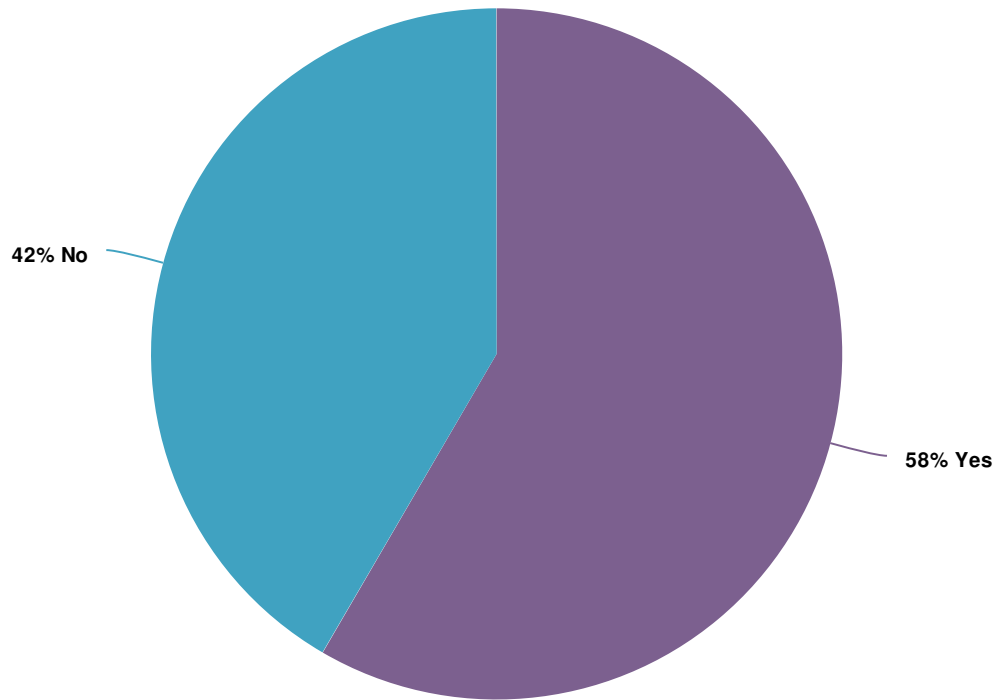

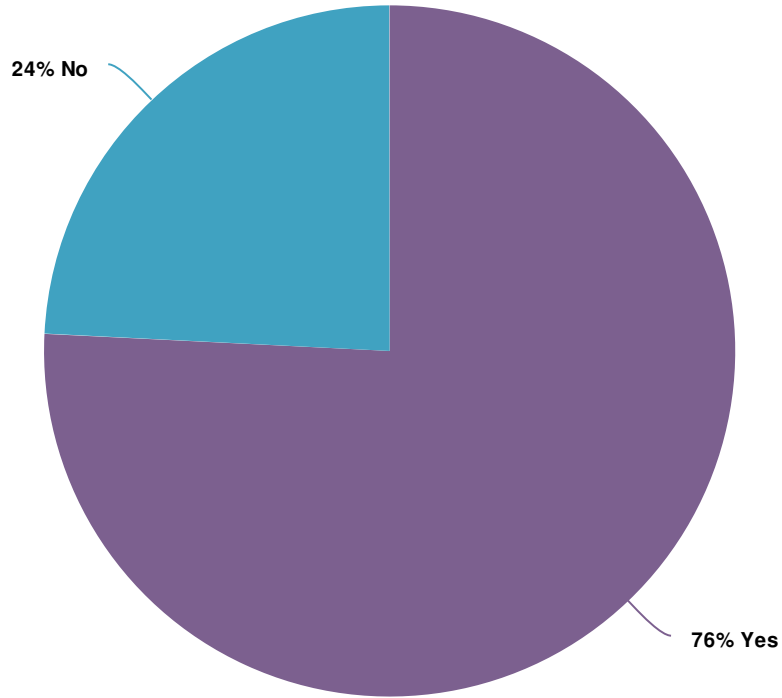
5. Do you own or are you currently planning on having animals at your property in Desert Aire?

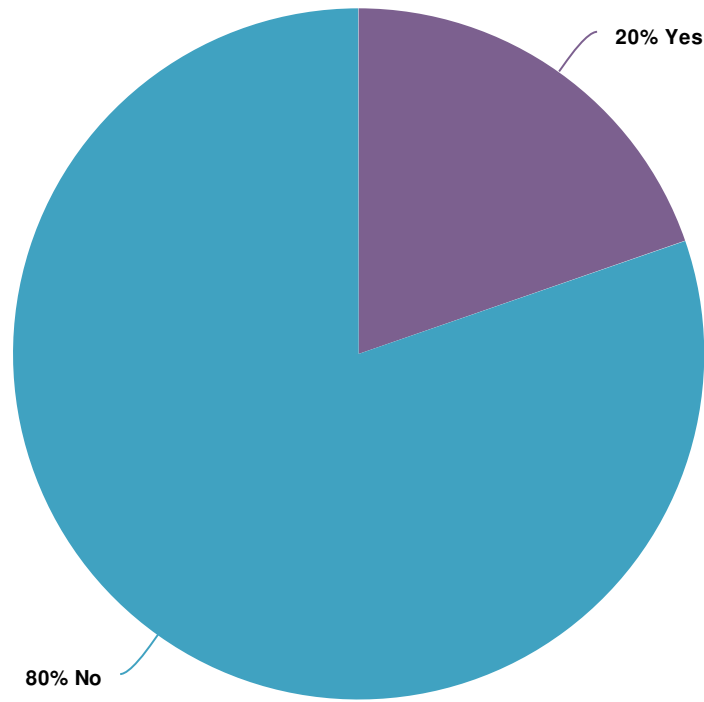
6. Have you noticed any stray animals in any area around Desert Aire, either at your property, on the golf course, roaming the streets, by the business district, around the airport etc?

7. Have you personally attempted to care or contain a stray animal to transport to a shelter or hold until authorities arrive?

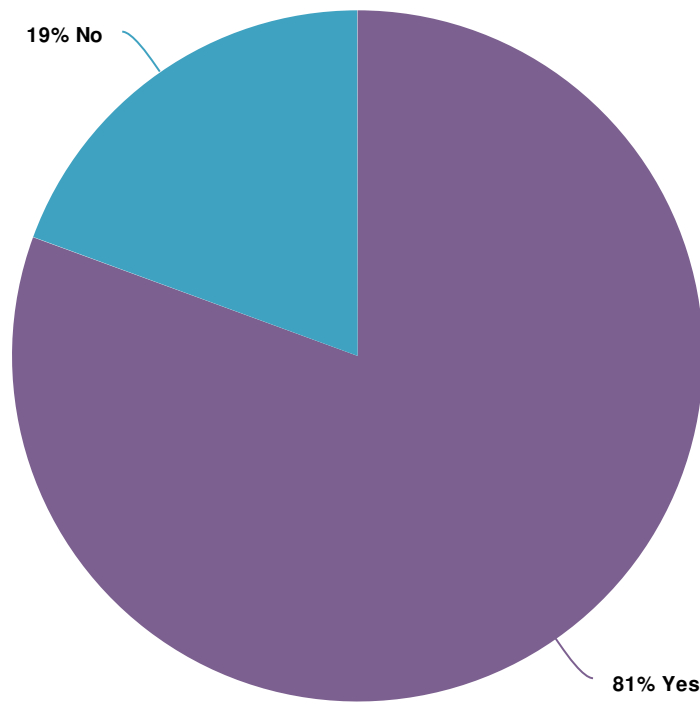

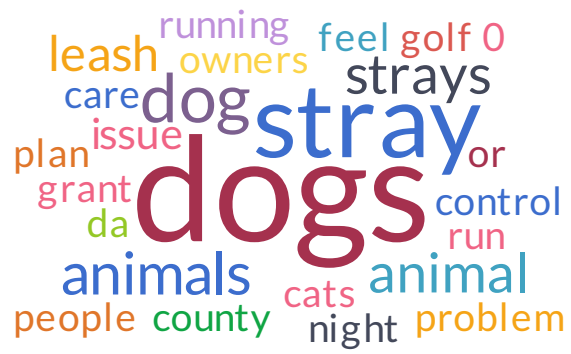
8. Would you support DAOA holding a meeting to collect owner input on developing a more localized plan to deal with the issue of strays in our community?



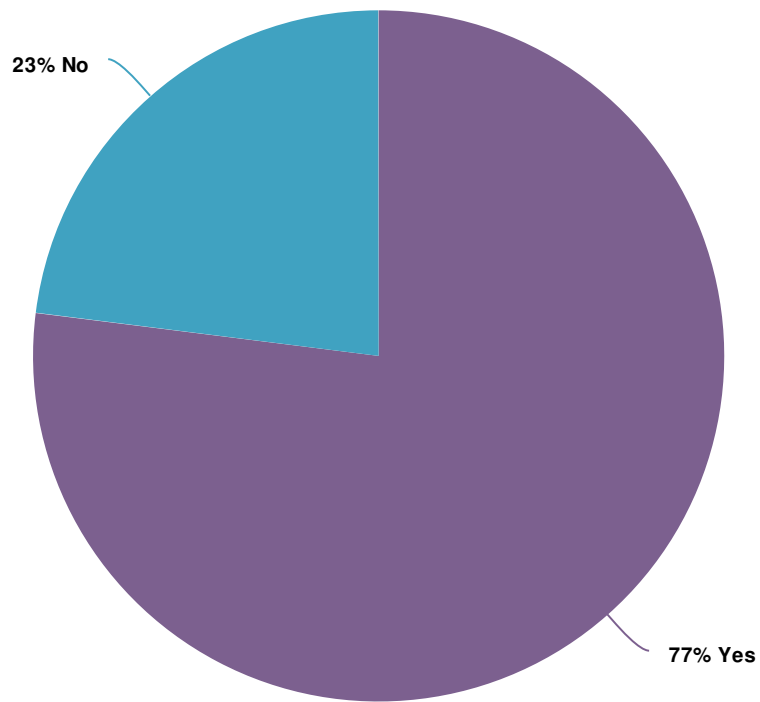

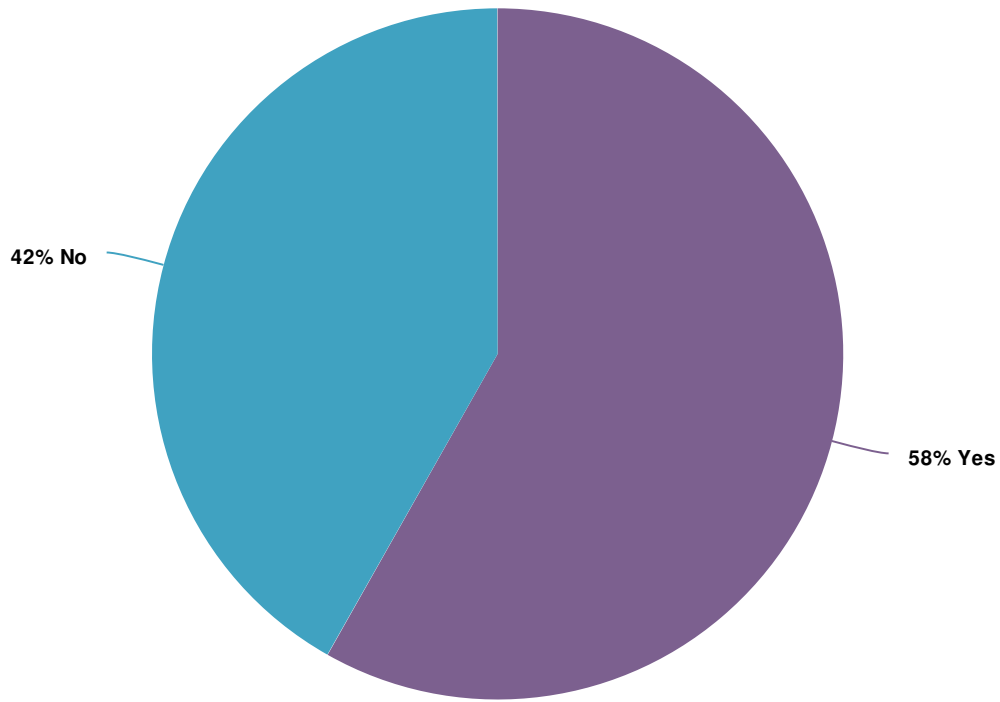
10. Do you support DAOA's efforts to create a revenue generating food service venue in the Snack Shack?

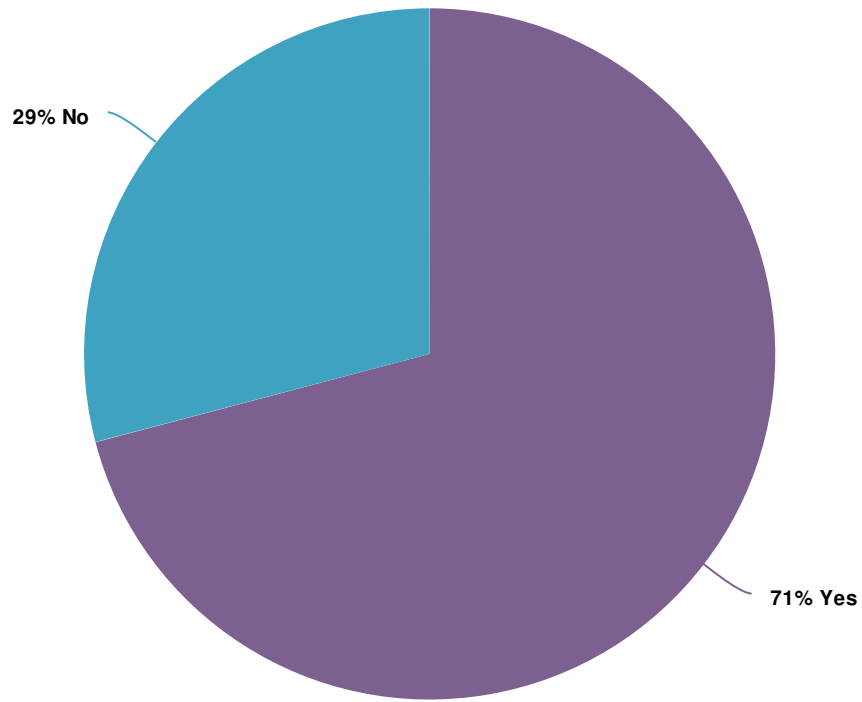
11. Do you support DAOA managing the venue (hiring staff, determining venue hours, determining menu items)?




12. Do you support DAOA leasing the facility to a qualified restaurant operator with a proven track record?



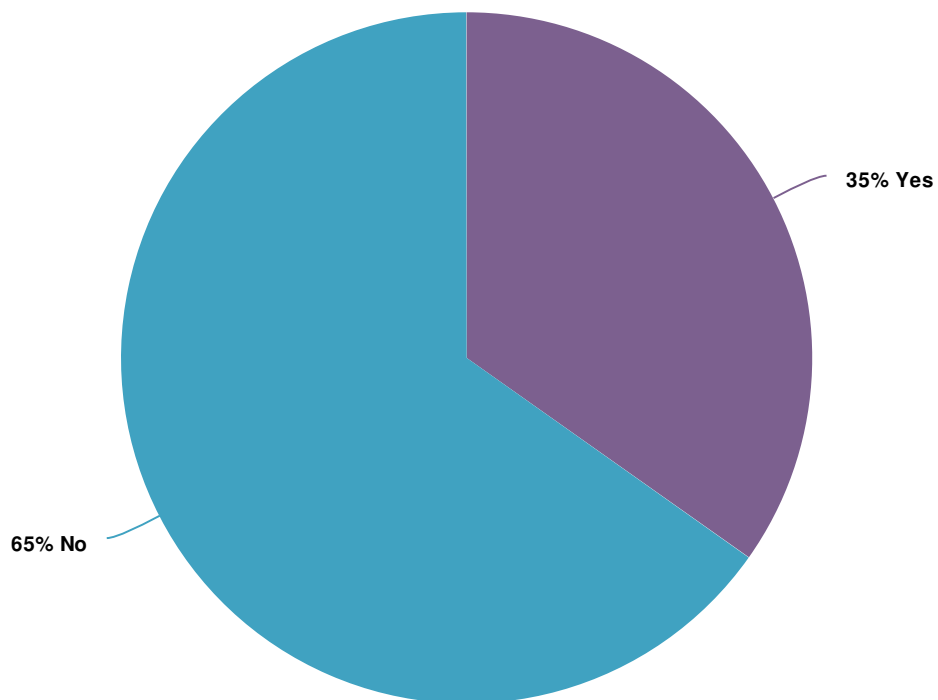

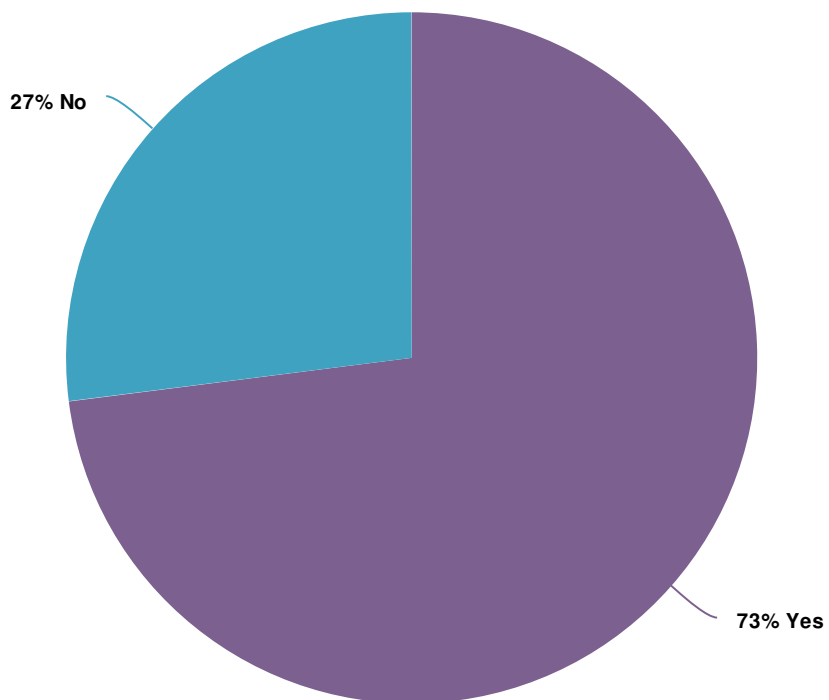
### 14. Do you have a fitness center membership?

15. Do you use it during the week?

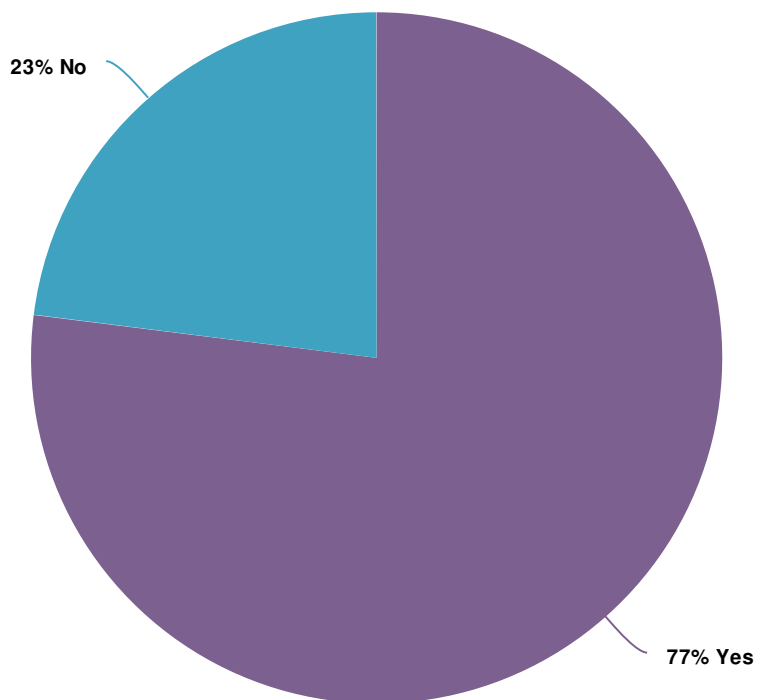

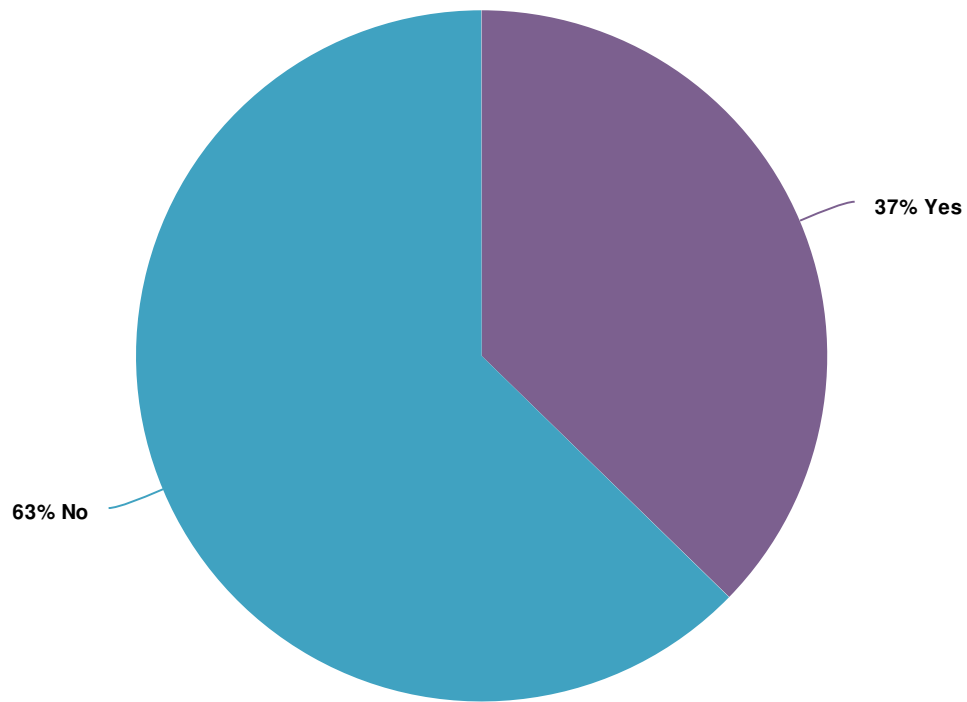




### 16. Do you use it in the mornings?



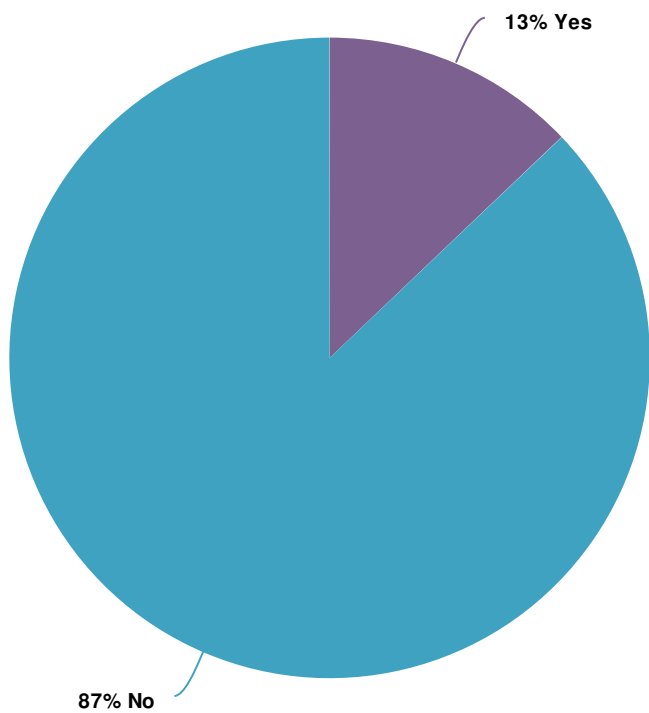

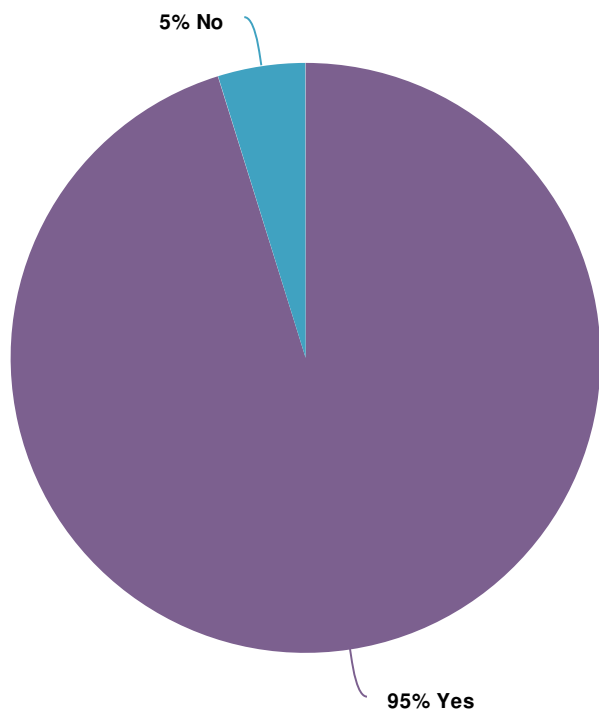
18. Do you use the center every weekend?

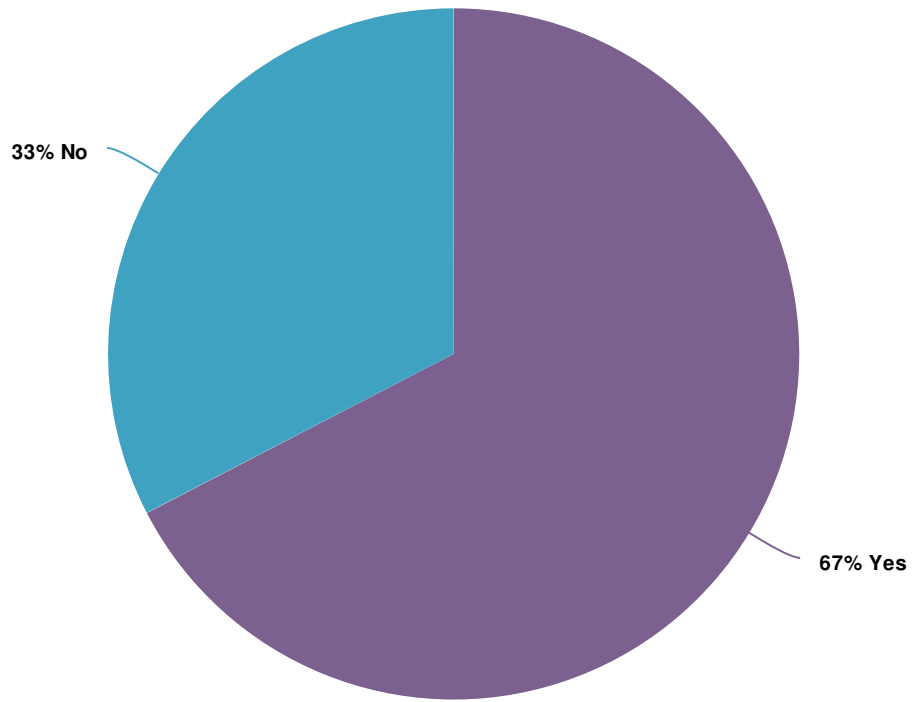
19. When using the center, do you have easy access to the equipment?



